

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to <https://c19tracker.org> and Helios Advertising Technology LLC and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Helios Advertising Technology LLC include <https://c19tracker.org> and Helios. The Helios website is a news and information site regarding Coronavirus site. By using the Helios website, you consent to the data practices described in this statement.

Collection of your Personal Information

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services available on the Site. These may include: (a) registering for an account on our Site; (b) entering a sweepstakes or contest sponsored by us or one of our partners; (c) signing up for special offers from selected third parties; (d) sending us an email message; (e) submitting your credit card or other payment information when ordering and purchasing products and services on our Site. Sharing Information with Third Parties

Tracking User Behavior

Automatically Collected Information

Information about your computer hardware and software may be automatically collected by Helios. This information can include: your IP address, browser type, domain names, access times and referring website addresses. This information is used for the operation of the service, to

Security of your Personal Information

Helios secures your personal information from unauthorized access, use, or disclosure. Helios uses the following methods for this purpose:

- SSL Protocol
